Applications are available at the Union Office, 475 North Service Rd E, Oakville or on-line at https://uniforlocal707.org/.

This scholarship is available **ONLY** to those students that meet the following criteria.

- 1. You must be the dependent son/daughter of a parent who is actively employed or of a retired member in good standing of Local 707 on the date the school term commences. (One application per *family*)
- 2. You must be entering into a year of post-secondary education or post-graduate certificate, degree/diploma at an accredited Canadian or U.S. university or community college as a full-time student and be able to supply proof of admission.
- 3. The claim must include an original paid fee statement or an original paid receipt for the current academic year showing student name, term start date, student status (full or part time attendance) and the amount paid for tuition fees along with this application.
- 4. If you have already received one of these scholarships, you are not eligible for another.
- 5. Scholarships will be drawn on Sunday, November 17, 2024.

Once completed, it must be returned as indicated on the application.

No one may receive more than one scholarship during the post-secondary interval.
