2. You must be entering into a year of post-secondary education or post-graduate certificate, degree/diploma at an accredited Canadian or U.S. university or community college as a full-time student and be able to supply proof of admission.
3. The claim must include an original paid fee statement or an original paid receipt for the current academic year showing student name, term start date, student status (full or part time attendance) and the amount paid for tuition fees along with this application.
4. If you have already received one of these scholarships, you are not eligible for another.
5. Scholarships will be drawn on **Sunday, November 16, 2025**.

**Once completed, it must be returned as indicated on the application.**

**No one may receive more than one scholarship during the post-secondary interval.**
